**\*\*Sheboyan Case Updates:**

- Sheboyan County currently has 77 confirmed cases of COVID-19. Of those, 65 cases have recovered and are no longer ill. No active cases are currently hospitalized.
- 3 confirmed cases are deceased. The individuals who passed away are in the 60+ age group and are associated with long term care facilities.
- Active cases** are defined as those individuals who are currently ill and requiring medical care or are in isolation.
- Recovered cases** are defined as confirmed cases where at least 3 days/72 hours have passed since recovery, defined as resolution of fever without the use of fever-reducing medications and improvement in respiratory symptoms, **AND** at least 10 days have passed since symptoms first appeared.
- Negative Tests** are defined as a COVID-19 test with a negative result that was reported to Public Health. For information on testing, see WI testing priorities and procedures section.

## TODAY'S KEY COMMUNITY PREVENTION MESSAGING:

### **\*\*Sheboygan County to Hold Mass Community Testing May 28th-30th**

In partnership with Sheboygan County Emergency Management and the WI National Guard, Sheboygan County Division of Public Health is planning to hold mass community testing events at the Sheboygan County fairgrounds from May 28-30th. We are currently working on the details of times, further directions and will provide that information as soon as those details become confirmed.

#### General Information about Community Testing Events:

- No appointment is needed for the testing
- Testing is free
- Testing will be done at the fairground and per drive-thru
- Daily testing capacity will be 400 tests
- Members of the Wisconsin National Guard will conduct the testing
- Testing is available for those ages 5 and older but minors must be accompanied by a parent or guardian who can consent to the testing
- The test determines if you currently have COVID-19 and is NOT an antibody test to tell if you have had it in the past or have immunity.

#### Testing is available for anyone with symptoms:

- Fever, defined as a measured temperature greater than 100.4°
- Cough
- Shortness of breath or difficulty breathing
- Sore throat
- Headache
- Chills or rigors (repetitive shaking chills)
- Myalgia (muscle aches)
- New loss of taste or smell

### Sheboygan County Safe Restart: **Phase One Business Recommendations**

**Sheboygan Safe Restart: PHASE ONE**  
**Business Guidelines and Recommendations**

Within **PHASE ONE** of the Safe Restart plan to open Sheboygan County, the following recommendations are in place for the **BUSINESSES**:

- Encourage masking of staff and public
- Encourage To-Go and Curbside Pick up to reduce in-store traffic
- Follow WEDC and CDC sector guidelines
- Limit to 25% of Capacity in non-essential businesses
- Support remote working and education
- Watch for updates on recommendations and progress
- Create spaces that allow physical distancing
- Stay Home when ill

- Wash your hands with soap and water or use hand sanitizer, especially after touching frequently used items or surfaces.
- Avoid touching your face.
- Sneeze or cough into a tissue or the inside of your elbow.
- Disinfect frequently used items and surfaces as much as possible.
- Strongly consider using cloth face coverings while in public, particularly when using mass transit.
- If you are sick, stay home- Do NOT go to work, school, or any other public place and follow the advice of your medical provider.
- Know where to find local information on COVID-19.
- Know the signs and symptoms of COVID-19 and what to do if symptomatic.
- Create a household plan of action in case of illness in the household or disruption of daily activities due to COVID-19.
- Follow public health quarantine/isolation orders when ill or when you are a close contact of someone with COVID-19.

Indicator	Metric	Status
Cases	Downward trajectory of positive cases of COVID-19 as a percentage of total tests	●
Testing	Testing availability for all residents with COVID-like symptoms, with priority toward vulnerable populations	●
Care	Hospitals have ability to treat all patients requiring hospitalization without resorting to crisis standards	●
PPE	Adequate PPE available to health care personnel	●
Tracing	Every resident who tests positive for COVID-19 is interviewed within 24 hours of test results, COVID positive contacts are interviewed within 48 hours of test results	●

## **Executive Orders/Press Release Updates:**

- On Tuesday, May 19th County Board Chairman Koch is asking the County Board to extend the County State of Emergency by 60 days. In summary, this does the following:
  1. Continue to raise awareness that we are in the midst of a health pandemic
  2. Authorizes the County Administrator to make expenditures as necessary for the health, safety, protection and welfare of the community (for example, purchasing emergency protective equipment)
  3. Acknowledges the County Board's support for the "Sheboygan County Safe Restart Recommendations"
  4. IF in the event we experience a surge in COVID-19 cases and our hospitals become overrun with cases, acknowledges County Board support for our County Public Health Officer exercising authority under Chapter 252 of the Wisconsin Statutes.
- County Board is NOT taking action to extend the Safer at Home Order, and is NOT putting an order or any other restriction in place.

- Lakeshore Community Health Care's (LCHC) main focus in ramping up services is the health and safety of patients and staff. LCHC is open for dental emergencies and medical care including an acute care clinic for symptoms related to COVID-19 and offering telehealth services for mental health care, medical and dental appointments. The pharmacy remains open with curbside pickup and free delivery options. LCHC will be calling all patients needing to be rescheduled due to cancellation from COVID-19.
